
INSTALLATION INSTRUCTIONS

MODEL 6131

ELECTRONIC SECURITY CONTROL





IMPRORTANT

THIS CONTROL HAS EFFECTIVE LIGHTNING PROTECTION ONLY WHEN GROUNDED ACCORDING TO THE FOLLOWING INSTRUCTIONS-

CONNECT EARTH GROUND TERMINAL TO A COLD WATER PIPE WITH NOT LESS THAN 18 ga.SOLID WIRE OR TWO CONDUCTOR 19-8ga. STRANDED WIRE.CLEAN SURFACE OF PIPE AND SECURE WITH A SUITABLE CLAMP.

DO NOT GROUND TO A GAS PIPE OR THE BUILD-INGS ELECTRICAL GROUND.

CUT JUMPER

J1 (GREEN) FOR DRY CELL BATTERY **J3** (BLUE) FOR FAST LOOP

BELL CUT-OFF TIME

THE BELL CUT-OFF TIME IS ADJUSTABLE FROM 2 TO 15 MINUTES.THE TIME IS ADJUSTED BY THE POTENTIOMETER LOCATED TO THE RIGHT OF THE ENTRY POTENTIOMETER.TURNING THE ADJUST-MENT WHEEL UP WILL INCRESE THE BELL CUT-OFF TIME.TURNING THE WHEEL DOWN WILL DECRESE THE CUT-OFF TIME.

PROCEDURE FOR ADJUSTING ENTRY/EXIT TIME

ENTRY AND EXIT TIME IS ADJUSTED BY TWO POTENTIOMETERS LOCATED IN THE UPPER CENTER OF THE CONTROL PANEL.TIME IS INCREASED BY ROTATING ADJUSTMENT WHEELS TOWARD TOP OF CONTROL PANEL.(UP).EACH 1/4 TURN OF ADJUSTMENT WHEEL WILL INCREASE TIME BY 15 SECONDS.ADJUSTMENT RANGE IS: 5 TO 60 SECONDS.

TO SET ENTRY TIME

TURN EXIT ADJUSTMENT TO MINIMUM(DOWN), THEN TURN ENTRY ADJUSTMENT 1/4 TURN (UP).ARM CONTROL WAIT UNTIL EXIT TIME EXPIRES, OPEN DELAY DOOR, PRE-ALARM SIGNAL STOPS AND CONTROL TRIPS, THIS IS THE ENTRY TIME.DIS-ARM CONTROL.IF MORE ENTRY TIME IS REQUIRED ADVANCE ADJUSTMENT ACCORDINGLY.

TO SET EXIT TIME

TURN EXIT ADJUSTMENT TO MINIMUM(DOWN), THEN TURN ADJUSTMENT 1/4 TURN(UP).ARM CONTROL WITH DELAY DOOR CLOSED.OPEN DELAY DOOR, WHEN PRE-ALARM SIGNAL SOUNDS, THIS IS THE EXIT TIME.DIS-ARM CONTROL, IF MORE TIME IS REQUIRED ADVANCE EXIT ADJUSTMENT ACCORDINGLY.
